Upon motion by Council President Burnside, seconded by Councilman Mulligan, and unanimously carried via roll call vote to give permission to the Borough Attorney to draft an ordinance for the Governing Body's review prohibiting underage drinking on private property.

The Garden Club is celebrating its 30th anniversary this year.

Upon motion by Councilman Vicente, seconded by Councilman Mulligan, and carried unanimously upon voice vote, to accept the Public Safety Committee report.

ATTORNEY'S REPORT

Approved the application for a license to be issued to Boro Limousine.

Upon motion by Councilman Mulligan, seconded by Council President Burnside, and carried unanimously upon voice vote, to accept the Borough Attorney's report.

MAYOR'S REPORT

Mayor Greuter attended a meeting of the Rockaway River de-snagging committee and received approval from the Council to meet with the Public Works supervisors to supply a worker for one day a week for July and August.

Mayor Greuter received a letter asking if the municipality would be interested in purchasing 27 Wall St. which was the site of a fire in December 2011. The Council decided there was not adequate need nor funding to purchase the property.

Mayor Greuter suggested that the Borough sell some municipal property, such as 35 Addison Ave., at auction. Councilman Mulligan recommended that a list of all Borough-owned properties be reviewed.

Thanked the Environmental Committee and Mr. Pat McDonald who spearheaded a great effort to have students from Lincoln School build birdhouses and students from Thomas Jefferson School build signs for the Beach St. River Park trail.

Mrs. Carol Johnson said that the Recreation Commission would like to select sand for the Park Lake beach. Councilman Donofrio will look at the sand samples.

Mr. Pat McDonald, 42 Crestwood Rd., described the other projects planned to be completed by volunteers at Lincoln and Thomas Jefferson Schools.

Mr. Robert Grow, 110 Lakeside Dr., showed some of the 15 bird houses and bird signs that the students painted for Beach St. River Park.

Mrs. Bonnie Hook, Jackson Ave., complained about the work that New Jersey Natural Gas had done in front of her house a few weeks ago with any notification to her. She suggested that a line be added to the road opening permit that they have to notify the homeowner or business when they will be working. Mr. Wacks will speak with the Borough Engineer.

Mr. McDonald asked if a second lane could be added to Jackson Ave. for left turns; Mayor Greuter replied that it is a one-lane roadway.
